



1. Why does New Orleans have persistently high murder rates?

2. Is New Orleans different from other cities in terms of murder risks?

3. What happened beginning in late 2019 in terms of the increase in gun violence/murder rates?

The Etiology of Murder in New Orleans

Causes Why are people shot in New Orleans?

- Drug disputes and transactions (Brownstein et. al)
- Gang, drug group turf battles, social networks (Papachristos)
- "Street Beefs," arguments (Slutkin)
- Domestic Violence (Sherman)



Patterns: Who gets murdered in New Orleans?

- About six neighborhoods in New Orleans have about 70 percent of murder victims in the city.
- About 80 % of gunshot victims have prior criminal arrests.
- Both "subjects" and victims demonstrate *low reading* levels and school *drop out* patterns.
- Both "subjects" and victims often have signs of substance abuse, mental illness, thinking disorders and similar crime histories.

Patterns:

Tipping Points and Gun Violence Control Policies in New Orleans

<u>Early 1990s:</u> Police Cartels, Taylor's Children, Antoinnettes, Mc Nuggets, "routes", Len Davis. Antoinette Franks case.


1994-1999: Pennington reforms: decrease in murders from **424** in 1994 to **159** in 1999(72% decrease.)

<u>2005</u>: Hurricane Katrina: Danziger Bridge and Glover cases 206 murders prior to advent of Hurricane Katrina few murders afterwards.

2010-18: Landrieu Administration Murder Gun Violence Policies: Nola for Life and the Consent Decree

Patterns Medical Cost of Gunshot Injuries

- Medical professionals serve a critical role in education, stabilization, and long-term care for non-fatal injuries.
- Key to thinking about the position roles is thought about the scope of preventive stabilization and long-term treatment efforts.
- Medical professionals play an important role in screening youth for involvement in armed drug involved groups and deploying crime prevention strategies such as Hospital based Ceasefire.


Results: What happened in New Orleans 2016-2019?

New Orleans reduced its estimated murder totals from 2016-2019-What happened?

- 2019 119 murders
- 2018 146 murders
- 2017 157 murders
- 2016 176 murders

New Orleans annual homicide totals, 2006-2020

The 195 homicides reported in New Orleans in 2020 are the third-most in a year since 2006, the year after Hurricane Katrina. That figure is more than 60% higher than the 121 murders reported in 2019, the lowest annual tally in 47 years.









Structural Inequality and Long-Term Gun Violence Trends:

Question: What part of the NOLA 2019-2021 gun violence surge represents inequality and structural factors (including schools, housing and healthcare) and how difficult is it to change without addressing these conditions?



• Is the 2019-2021 NOLA gun violence surge related to the medical, economic and social impact of the COVID pandemic?



De-policing and criminal justice ambivalence as influencing the 2019-2021 murder surge.

• Question: Did the NOLA 2019-2021 gun violence surge reflect conflicts in City Criminal Justice policy, closing of courts and depolicing by N.O.P.D. officers?




Did departure from Intelligence-Led Policing practices, proven effective from 2016-19 have an impact on gun violence risks from 2019-21.

Question: Did changes/ retreats in police practices from NOPD Intelligence led strategies in use from 2016-2019 have an impact upon increases in gun violence from 2019-21?




Other Factors to consider to explain NOLA 2019-2021 Murder Surge.

- Instability and conflict in illegal drug markets during" close-down?"
- Expansion of youth population considered disengaged in the aftermath of COVID?
- Reflection of national "Black Lives Matter" and " Defund the Police" Movements on New Orleans Criminal Justice Policy?
- Court Closings, deferred prosecutions?
- Regression to the mean?



Logic Model



Steps Needed: Agenda for Change- above all get the numbers straight.

- 1. Agenda for Change- above all get the numbers straight.
- 2. Analyze "as is" gaps, inconsistencies in definitions, sources of sampling error and anomalies in the "as is" New Orleans gun violence reporting systems in place.
- 3. Convene metro NO medical and criminal justice stakeholders to assess needs for an integrated gun violence registry and define obstacles to overcome.
- 4. Implement consistent metrics among disparate databases into a comprehensive and interoperable gun violence registry, for use by criminal justice, medical, Federal and other gun violence policy stakeholders.
- 5. Develop action plan with key performance indicators with clear accountability to reduce gun violence.

Next Steps: Sustaining Reductions in Gun Violence- can New Orleans permanently reverse gun violence rate?
