## NEWS

- On October 1, 2024, NIH will issue new DMS questions that align with the [NIH Final Policy on Data Management and Sharing](#), asking recipients for updates on the status of data sharing, repositories, and unique identifiers for data that have been shared. Note that RPPR users who have initiated but not submitted their RPPR as of October 1, 2024, may need to redo the revised C.5 section, which will be split into C.5.a (Other Products), C.5.b (Resource Sharing) and the new C.5.c (DMS) section under the C. Additionally, to prepare for the APHA meeting, SPH Research Presentations will include two sessions: Oral Presentations on October 18th at noon, and Poster Presentations on October 21st at noon. These sessions are open to all students, staff, and faculty attending the APHA meeting, offering an excellent opportunity to present their work.

- The seminar about “Maternal and Child Health in the Face of Climate Change: Lessons Learned Locally,” hosted by Dr. Reed in collaboration with the Southern Center for Maternal and Child Health Equity and Minority Health Equity. The keynote speakers Dr. Tyra Gross and Kennedy Copeland, who emphasized breastfeeding support during crises like Hurricanes Laura and Ida. They also discussed their recent publication in the Journal of Human Lactation. The seminar attracted attendees from universities and community organizations, including representatives from WIC and DePaul Community Health Center.
