Emphasizing interdisciplinary and transdisciplinary approaches, the program cultivates a deep understanding of the intersection between veterinary medicine or social work and public health. This dual degree program is crafted to equip graduates for diverse interdisciplinary career environments, aligning with the CDC's One Health initiative. - The deadline to apply to the LSU School of Public Health for the One-Health online track is **July 15**. Acceptance is for the Fall semester.
- MPH application form including:
  - Signed Release of Admissions Records from LSU School of Social Work or LSU School of Veterinary Medicine
  - Resume or CV
  - Statement Stating Why You Wish to Pursue an MPH Degree
